They maintained that they worked as permanent employees continuously from 2006 to February 2011, on the basis of temporary contracts. We note some of the Claimants have started legal actions against the Insured. On 03 April 2012, the Court of Alexandria upheld the petition filed by Ms [REDACTED] condemn the Insured to pay EUR 18,967.10 over legal costs (EUR 1,800). The Insured has appealed the Court's decision. The next hearing has been scheduled for 07 February 2013. The Court of Alexandria on 29 September 2012 rejected the petition filed by Ms [REDACTED]. The first hearing of the proceedings started by [REDACTED] e [REDACTED] has been scheduled for 8 May 2013. Finally also Ms [REDACTED] started a legal action against the Insured. 2012MRK00655	ASL AL	10205626R	01/01/2008	The events that gave rise to the present local action can be summarized as follows: On 21 April 2004, the Claimant was appointed for a term of up to 5 years as Director of the Department of Psychology of the "Local Health Unit (ALS in Italian) of Alexandria 21", one of the three local health entities of the Province of Alessandria. On 1 January 2008 the Lombardy Region adopted a decision by which the three said entities were consolidated into a single unit, named simply "Local Health Unit (Asl) AL", the Insured Entity. On 30 June 2008 the Insured Entity adopted its own procedural rules and organization. As a result of the consolidation, the Insured Entity had to establish only one Department of Psychology, organized in different areas, with a single Director coordinating the subordinate Directors of the various areas. Starting from 1 January 2008, the Claimant has performed the role of Coordinator of the directors of the various areas. She also organized training courses and work groups for the said individuals. The Claimant complained of having been hampered in her activity by both the Medical Director and the General Director of the Insured Entity. According to the Claimant, in fact, the General Director adopted decisions in breach of the rules set out on 30 June 2008 when the new Entity reorganised itself and adopted new procedures. In particular, the Claimant alleges that the General Director failed to set up a single Department of Psychology and, as a consequence, she has never been officially appointed as the sole Director of the Department of Psychology, even though she has unofficially performed the tasks and functions of that role. The Claimant alleges therefore that the General Director of the Insured Entity is liable for having violated the act adopted on 30 June 2008. We note that the Claimant stated that the said act has to be considered as an employment contract between her (the employee) and the Insured Entity (the employer). The Claimant insists that the Insured Entity is liable for the damages she suffered not only for the violation of the rules and procedures introduced on 30 June 2008, and thus for contractual liability, but also for the Insured's unlawful conduct and thus for extra contractual liability. The Claimant alleges to have suffered pecuniary and also non pecuniary damages due to the decisions and acts adopted by the management of the Insured Entity: On 31 October 2011, the Claimant filed a petition against the Insured before the Labour Court of Casale Monferrato, asking the Court to order the Insured Entity to appoint her as Medical Director of the Psychology Department and, as a result, to compensate her for the patrimonial and non patrimonial damages she alleges to have suffered. The first hearing was scheduled for 8 June 2012. - to be partially denied. The next hearing has been scheduled for 25 February 2014. The Court will examine the witnesses.
